3. TOWN OF ADMINISTRATOR'S UPDATE

- a. Economic Development Coordinator Introduction: Jeanne LeClair J. LeClair is the new Regional Economic Coordinator. J. LeClair explained what her role as the new coordinator for the Hill Towns. J. LeClair has toured the other five towns and will be touring Blandford August 9th at 1:00pm.
- b. Franklin Regional Transit Authority(FRTA): Tina Cote
 Tina was unable to make the meeting. F.R.T.A. operates 5 days a week providing curb to
 curb services for the 60 and older to prescheduled appointments. Council on Aging
 discussed a driver issue. F.R.T.A. is contracted with Huntington. Select Board would like to
 speak with Huntington regarding the contract.
- c. MIIA Certification list: The Board agreed to have it distributed
- d. Pioneer Valey Planning Commission S Johsua Garcia introduced Eric Kinsherf for discussion of what he can offer the town. Kinsherf currently has five towns that he services. All accountants are well educated; he is familiar with Softright program. Kinsherf would come in frequently but mostly remotely balance and close the books and town would be responsible for processing warrants.
 - The initial assessment is \$1,500.00 and Kinsherf will send over a list of questions. Eric felt that by September 30, 2017, he would have an assessment and how to proceed.
