Russell Stage Road - Mill & Fill

DATE: July 2, 2018

The Town of Blandford, MA ("Town") acting through its Highway Department invites sealed bids for Russell State Road, Mill & Fill. Only those contractors who have been pre-qualified by the Mass DOT will be allowed to receive a bid package on this project. Specifications for this job are outlined on the attached Bid Proposal Form and must be strictly followed. No modifications will be allowed. All bid proposals must be made on the Bid Proposal Form and must be complete. Incomplete submissions will be deemed non-responsive and will be rejected.

All bids must be accompanied by a bid deposit of five percent (5%) of the bid price in the form of a bid bond, cash, certified or cashier's check issued by a responsible bank or trust company, payable to the Town of Blandford. Bid bonds shall be with a surety company qualified to do business in the Commonwealth of Massachusetts and shall be satisfactory to the Town.

Completed Bid Proposal Forms must be received by 4:00 PM on July 23, 2018 at the Office of the Board of Selectmen located at One Russell Stage Road Blandford, MA. Bids will be publicly opened and read aloud at 7:00 PM on July 23, 2018.

Proposals must be sealed and clearly marked Russell Stage Road Mill & Fill Project. Bids received after the deadline will be returned, unopened. Corporate bidders must submit an executed Certificate of Vote (form attached to Bid Proposal Form) stating that the person signing the bid has the authority to bind the corporation. Bids may not be withdrawn within 30 days excluding Saturdays, Sundays, and Holidays after the actual date of the opening of the bid.

At the time of the opening of the bids, each bidder will be presumed to have read and be thoroughly familiar with the specifications for this project. The failure or omission of any bidder to examine any form, instrument or document shall in no way relieve any bidder from any obligation in respect to their bid.

Each bidder shall inform themselves of the conditions relating to the project and the employment of any labor thereon. Failure to do so will not relieve a successful bidder of their obligation to furnish all equipment, material, and labor necessary to carry out the provisions of the contract.

All bidders must submit with their bid a completed and signed Non-Collusion Certificate which is included in the Bid Proposal Form.

The Town may make such investigations as it deems necessary to determine the ability of any bidder to perform the work, and the bidder shall furnish to the Town all such information and data for this purpose as it may request. The Town reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy it that such bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein. Conditional bids will not be accepted.

A contract for the project in the same form as that enclosed in this package will be awarded within thirty days by the Board of Selectmen to the qualified, responsive bidder with the lowest total price for the project. The Town reserves the right to reject any and all bids.

This project is subject to Section 26-27G of Chapter 149 of the Massachusetts General Laws as amended, including, but not limited to, the following:

- Prevailing wage rates as determined by the Commissioner of Labor and Industries must be paid on this contract. A copy of said rates is contained herein. All reports and records required shall be maintained and/ or submitted by each contractor and subcontractor.
- The successful bidder shall furnish to the Town a one hundred percent (100%) Construction Payment Bond with a surety company acceptable to the Town.
