Open Meeting:

7:00 p.m. Mr. Dolby called meeting to order, provided notice that meeting may be recorded.

Posted Agenda Items:

- **1.** Planning Board: revisit next week.
- **2.** Financial Officers Closing FY15 Books: planning to close mid-October. Building out process for next year with Mrs. Sarnelli.
- **3.** Minutes: Mr. Montanaro motion to approve meeting minutes of August 31, 2015, Mr. Dolby second, unanimous vote.

Old Business:

- 1. School Committee Job Description: Mr. Montanaro motion to accept School Committee Job Description as amended on the document dated September 14, 2015, to go into effect on October 5, 2015 unless the Selectboard receives any amendments from the School Committee to consider, Mr. Dolby second, unanimous vote.
- 2. Highway Garage: the contaminated soil has been transported to Ondrick. We are waiting on lab tests to conclude level of contaminate in the soil. Alan Weiss reported that some odor remained below the pillars of the garage. We will go to EPA with results.
- **3.** Building Planning/Safety Complex: scheduling meeting with DOT.
- **4.** BRD Bond Negotiating: Treasurer- will be renewing the bond until June, hoping to pay it off early with FEMA reimbursements. Will be also doing both bond renewals on the same date to save money. Bids were put out today.

- **4.** Vocational Transportation Bid: Town Administrator in Chester offered to manage a shared bid. Mr. Dolby motion to collaborate with Patricia Carlino for a vocational transportation bid contract, Mr. Montanaro second, unanimous vote.
