# c. Notice of Intent to sell Pursuant to M.G.L.ch.71b by Owner/s of plot located on Chester Road; ID #408-0-13. Board of Selectmen have first right of refusal.

Josh Garcia presented a Notice of Intent to sell to the BOS which is 75 acres off Chester Road to be sold for \$164,000. B. Levakis recommended the Town purchase the property. E. McVey pointed out that the Town is in no position to purchase the property as logging property nor does the Town have any interest in dealing with selling real estate. It is recommended by B. Levakis that the BOS walk the property before it is sold. E. Mcvey noted that we will arrange a time to walk the property with the Conservation Commission, the Planning Board and the Selectmen under our rights within the next 120 days.

#### 4. UNFINISHED BUSINESS FROM PRIOR MEETINGS

# a. Presentation from Novak Consulting of Shared Police Report

Novak Consulting and Eric Weiss, Pioneer Valley Planning Commission presented a power point presentation to the Board of Selectmen, town residents, the State Police and Daniel Ilnicky, Chester/Blandford Chief of Police. Novak pointed out the cost savings in equipment, vehicles and this arrangement will allow a larger pool of officers patrolling our towns. As police responsibilities become more and more complicated, the training costs will be cut as well as the many administrative functions. Novak noted that as long as this arrangement is agreed upon by the residents of the town and is an agreement that is both equitable and fair to each town, this should work very well. Novak Consulting made a reference the Hilltown's long history of collaboration starting in 1949 when we first started talking about a joint school district which opened in 1963, we have the Hilltown Collaborative which has been fostering collaborative efforts among the six towns, we have hired an economic development organization, we have looked at shared finance operations, and we now have the Hilltown Community Ambulance Association working for us. It was pointed out that Chester/Blandford is in a very unique situation as we are small police department with low crime rates with coverage from State Police and we are currently sharing the same Police Chief.

C. Letendre asked for input from community members who attended the meeting. The audience asked several questions to Novak, Chief Ilnicky and the Board of Selectmen and they were all positive about this project.

E. McVey commented on the grant possibilities that are available at this time. Eric Weiss noted that that there are 2 ways PVPC can help out 1) next phase of the DLTA Grant that helped get us to this point and 2) PVPC will give a shot at the efficiency and regionalization grants. The PVPC stands ready to help our town.

# a. Review all Department Expense Report

Josh Garcia presented the board with the current All Department Expense Report for their review and action.

Josh Garcia issued the next package in the Financial Management Policies manual for the Board of Selectmen to review and comment before distributing to the Town departments.

## c. P. Langmore – Update Broadband Project

Peter Langmore of the Municipal Light Board presented an update on the Broadband Project in Blandford. He touched on several points in the progress:

- 1) The cable design for the network is nearing completion for the whole town, except Route 23 south of the turnpike. They are working with Otis to get this completed.
- 2) They will meet with Westfield Gas on January 28. At this time they will go over the pole design and will submit the pole applications.
- 3) E. McVey pointed out the importance of reaching out for rural development grants in a timely fashion.
