#### m. Annual town Meeting - Mullin Rule Adoption – Planning Board

The Planning Board is requesting that the Town adopt the following statute known as the Mullin Rule to help the committee adhere by MGL laws when members of municipal boards or commissions who are absent from no more than one session of an adjudicatory hearing may still act on the matter at future session, provided that the municipality accepts this section of the law and that the absent member reviews a transcript or video or audio recording of the hearing and certifies that they had done so. The final version of this proposal will be presented at the next Select Board meeting for approval at the Annual Town Meeting.

Jennifer Girard joined the Board and reported that the Hilltown Community Health Center is offering free vaccines to all town residents in surrounding town. Call 413-667-3009 for an appointment. Girard talked about opening the Town Hall suggesting we wait until May 29 to open to the public. She presented the reopening recommendations from Governor Baker's office. The Select Board agreed.

There was one internal and one external candidate considered. Both candidates had much to offer, however, the internal candidate is believed to be a better fit by the Advisory Board. Ackley, McVey and Letendre would like to see us proceed with the internal candidate. This interview will proceed on May 17, 2021 at the regular Select Board meeting.
