4. ACTION ITEMS

a. Review and Accept the FY20 Audit Management Letter and the FY20 Financial Statements as presented by Scanlon and Associates, LLC.

Jeff Gendron, Scanlon Associates joined the Board to discuss the FY20 audit reports. The Board reviewed the financial pages and management letter.

Financial Pages – Negative Opinion:

- No Capital Assets recorded or provided to Scanlon. Although it was noted that the Town received a \$20,000 grant and contracted with the Collins Center to work on created a capital improvement program.
- No retirement health insurance information reported which is not up to AICPA Guidelines (OPEB) Gendron noted that although these are 'negative' opinions, this is something the Town accountants and the town treasurer have been working on noting that this is an long-term project that they have been working on.

Management Letter - No material weakness or deficiencies:

- Great improvement from previous years
- Recommend staying current on reports
- Work on getting a plan in place for Capital Assets
- Department records should be easily available; had to search
- Free Cash and Stabilization in good shape being a significant portion of Blandford's budget creating a safety net for the town

5. UNFINISHED BUSINESS FROM PRIOR MEETINGS:

a. Sperry Road Repair

The Board reviewed previous discussion about the problems on Sperry Road. Ackley reported that there is a bylaw question he has been working on and is not quite done. Letendre asked to table the discussion until we have finished researching the bylaws.

b. George Millard Road Drainage

Joseph Stetz of 12 George Millard Road joined the Board to discuss the drainage problems on George Millard Road. He explained the history of improvements on his property and the work they had done in their barn area years ago explaining that he has done no work recently on his property and stated that this problem is more recent. He reported to the board that he watched while the previous highway superintendent from several years back and a George Millard resident removed the culvert from the road. He is sure this is when the problem started and has continued to get worsen over the years. T. Ackley suggested we hire an engineer to get to the bottom of this problem. D. Waldron, Highway Superintendent will make contact with an engineer. Letendre

suggested a Select Board member, the Highway Superintendent and the Engineer should have an on-site meeting regarding this problem.

b. Presentation from the Town Accountants & Treasurer/Collector on Finance Forecasting

Eric Kinsherf CPA, Sara Hunter, Treasurer/Collector and Andrea Turkelsen, Accountant joined the Board to present Blandford's Financial Forecast.

c. D. Waldron - Update on Rain Damage

Waldron reported on the roads in Blandford that are showing rain damage noting that the damage on most roads is minimal and his department is working on the problem areas. Waldron discussed culvert problems with the Board. Letendre believes after investing so much in our roads as we have in the last 3 years, we should invest in a company that has the equipment to clear out these culverts a couple times a year instead of waiting for a problem to develop. Ackley mentioned that part of the problem is that these culverts are on private property which would require an easement from the property owners in order for the Town to enter their property.

d. Old Chester Road

Garcia mentioned that he and Waldron have discussed closing the bridge on Old Chester Road in the Winter. This will be on the next agenda August 2, 2021.
