# a) Highway Department - Dave Waldron

- -The plow-request letters have not been received from Maple Lane or Beagle Club. The Highway Department will plow the road doing the best they can under the deteriorated circumstances.
- -Highway has been working on Gore Road. There is water running into the road that will be filled with asphalt to hopefully eliminate the problem.
- -Highway will put cones out on Russell Stage Road as a warning when ice builds up. Letendre requested Waldron to order a slow-ice sign.
- -Waldron mentioned that it was reported to him through the Facebook grapevine that somebody was reporting icy conditions. He is requesting residents call 911 to report this to the State Police after hours as the Highway Department does not look for information on Facebook.

# a) Animal Inspection vehicle

Letendre reported that recent information came to the attention of the Town Administrator. The State Animal Inspector has been using this vehicle in this position. Dunne investigated our Vehicle Use Policy which clearly states that the vehicle is for on-call or for those who may need the vehicle for emergency purposes. Dunne stated that the Animal Inspector position requires that the Inspector drive around Blandford and check the condition of animals in town. She is not involved in emergency animal services. Dunne is requesting the vehicle be returned to Blandford so this situation can be cleared up as there seems to be a lot of confusion around this retired cruiser.

## b) Septic repair funds

Dunne reached out to the Town's auditors requesting they investigate this fund to see if there are remaining funds. They stated they did not have any insight as they were not involved with this Trust fund Account. Dunne will work with the Blandford's Town Treasurer to see if this can be worked out. Dunne also reached out to Pioneer Valley Planning about the Community Development Block Grant that we currently have for housing rehabilitation. They said they could potentially take on a couple more projects.
