<u>Update Letter:</u> The National Opioid Litigation involves opioid manufacturers and distributors and are currently receiving allocations of settlement funds based upon negotiated settlements arising from such litigation. As you are aware the National Consortium of attorneys representing this litigation is seeking authority to amend existing litigation complaints to add additional counts against new defendants based upon the roles of Pharmacy benefit managers of a possible opioid crisis and their alleged failure to undertake the duties of monitoring opioid prescription practices. Authorizing such an amendment would permit cities and towns to participate in that expected litigation and possibly will benefit from settlements of judgements with respect to those additional defendants and whether to authorize the Amendments is a policy decision for the city or town, however, the decision must be communicated to the Consortium on or before May 1 7, 2024.
