3. DEPARTMENT REPORTS

a) Highway – D. Waldron

Backhoe: Waldron reported it would be \$2,700 to repair.

<u>Safety Class</u>: The Highway crew will be going to a safety class and trained on the chipper which should give us some insurance credits with MIIA.

<u>Tighe & Bond:</u> Waldron spoke to them about Schoolhouse Hill Road. An estimate for design is \$80,000 to redo the entire road over, better drainage, etc. Letendre inquired if anybody lives on that road. It could be up to \$500,000 to do the entire road. The road is not passable at this time. The Board does not believe this would be a beneficial use of funds at this time.

a) Springfield Water & Sewer - Cemetery Gate - Tabled

Letendre reported Nicole Sanford could not be here this evening. Springfield Water wants to formulate a new authorization letter for Cemetery Commissioner's access to Warfield and Stannard Cemetery so that it can be posted on the commission's property. Sanford is working with Pete Sparks. Sandford stated if Blandford is considering opening and removing these gates, we should consult Conservation and the Fire Department. Rescheduled for July 15, 2024. Cousineau reported Blandford was supposed to get keys for those gates and that never happened for the Cemetery. Cousineau is not sure about the Fire Department. Cousineau also believes it would be okay if Springfield Water leaves the gates in place but leaves them unlocked for Blandford's easy access but protected otherwise.
